#### Philanthropy in China: Investing in Social Impact

Philanthropy is a relatively recent phenomenon in China, arising primarily after the economic reforms of the 1980's and environmental disasters and regulatory changes in the last decade. Since then, individual, family, and institutional Chinese donors have increased in number and visibility. Approximately 3,000 philanthropic foundations currently operate in China. Concurrently, the rise of social media and information technology requires greater transparency and accountability from philanthropies. Chinese philanthropies are also in need of talent, best practices, and sector infrastructure to increase social impact and economic development. Businesses based and operating in China recognize the value of investing in communities that sustain their work. Panel speakers will

discuss the changing landscape of philanthropy in China and opportunities to establish Chinese philanthropy as a critical factor in social and economic

development.

U.S.-China Cross-Border Investment: Innovation and Technology Trends
Between 2000 and 2013, Chinese direct investment in the United States has
totaled \$25.4 billion while U.S. investment into China amounts to \$354.58 billion
in the same period. As the world's largest markets, China and the United States

are key destinations for cross-border investment. For China, investing in the United States allows Chinese companies to diversify beyond domestic markets and benefit from American innovation. For the United States, investing in China allows American companies to expand the scale of production and benefit from low-cost labor. Cross-border investment is a critical driver of both countries' future growth. As China pursues high quality growth and investment in the 12th Five-Year Plan's Strategic Emerging Industries – new energy, energy conservation/environmental protection, biotechnology, new materials, next-generation IT, high-end equipment manufacturing, and clean energy vehicles – it will require American capital and expertise. This roundtable will examine bilateral investment trends in innovation and technology and discuss the outlook for foreign investors in China.
